### **Minutes of September 13, 2006, Joint Business Meeting with the SoCal Fire Prevention Officers (California Fire Chiefs Association)**

**Location:** LAFD Frank Hotchkins Memorial Training Center, 1700 Stadium Way, LA, 90012

**Welcome and Call to Order:** The City of Los Angeles Fire Chief, Bill Bamattre provided the opening welcome to start the meeting. The business meeting was call to order by the President of SoCal FPO, Ken Quick and ICC LA Basin Chapter President, Felipe Segovia at approximately 10:00 A.M. The business portion of meeting was abbreviated to accommodate the long program.

**Roll call of ICC LA Basin Chapter Board Members in attendance:** The roll call of Board Members: President, Felipe Segovia, City of Torrance; Vice President, Tim McCormick, City of Santa Monica; Treasurer, Craig Johnson, City of Culver City; Secretary, Steve Ikkanda, City of Los Angeles, and Past President, Stuart Tom, City of Glendale were all present.
