On February 11, 2010, during our scheduled monthly meeting, the general membership of the ICC-Los Angeles Basin Chapter unanimously voted to support the Board's chapter recommendation for her continued appointment. Ms. Jamison currently fills the Fire Official position on the Commission, where she has been successful in bringing a well-balanced perspective to California's code-development process.
