3. Discussion Of Code Adoption Time Line And Future Meeting Schedule And Frequency. It was agreed that the committee would meet every other Tuesday from 1 pm to 4 pm at the LA County Building in Alhambra commencing with this meeting. The next scheduled meeting will be March 2, 2010. It is the goal of this committee to formulate any review and amendments by early June so as to provide those jurisdictions that are looking to use the amendments ample time to go through their jurisdictions code adoption process.
4. Assignment. With the understanding that the IBC will be reviewed first and the IRC second, the members agreed to assign individual chapters in the IBC to selected members and will do a group review of the IRC together. The assignments are as follows:

5. Open Discussion.
 - Option to use CRC or CBC for SFD/Duplex. Although the general consensus of the group was to require only the CRC for SFD/Duplex design, it was also understood that there is nothing in the code that stipulates that. The committee may consider developing a policy to address this issue or defer to the CRC committee.
 - Two-story SFD/Duplex without a CA licensed professional. The general consensus of the group was to limit the prescriptive design requirements to 1-story. Truong reminded the committee that this task was already initiated with the CRC committee and should remain there. Two committees with different opinion will only add confusion. Philip will convey any concerns the Structural committee has to the CRC committee. Jonathan was present for this discussion. He indicated that there is ongoing discussion with one of the original member, Kelly Cobeen, that help to develop the prescriptive provisions that eventually became the IRC's provision. He tentatively plan a teleconference call on March 1st. Any items that the committee wish to have Kelly address during the call should be forwarded to Jonathan. It was generally agreed that the issue will be addressed by the CRC, but the details of implementing or proposing amendments based upon that decision, will be deferred to the Structural committee.
